Information clause for a person joining the National Trade Union of the Self-Employed "wBREw"

In accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), we would like to inform you that

1. The Administrator of your personal data is the National Trade Union of the Self-Employed "wBREw" registered in Poznań, Żbikowa 14, www.wbrew.org, tel. +48 501 01 01 01.
2. In matters related to the processing of your data, including the exercise of your rights and withdrawal of consent, you can contact the Administrator at the e-mail address: rodo@wbrew.org.
3. Your data will be processed for the following purposes:
 - consideration of the membership application, and then membership of the Union on the basis of the membership application and acceptance of the Trade Union Rule Book (Article 6 (1)(b) of the GDPR) for the duration of the membership and possibly pursuing civil law claims or providing defense against such claims,
 - processing of membership fees, if introduced, in connection with membership of the Union, and in accordance with the relevant legislation (Article 6 (1)(b) and (c) of the GDPR) for the duration of the membership and thereof for 5 years following the year of the last contribution,
 - receiving information about events and other activities organized by the Union on the basis of your consent (Art. 6 (1)(a) of the GDPR), the data will be processed until the withdrawal of consent,
 - receiving information about the products and services of other entities related to the promotion of knowledge on the basis of your consent (Article 6 (1)(a) of the GDPR), the data will be processed until the withdrawal of consent,
 - receiving electronically, including to the given mobile phone number, marketing information and survey inquiries from the National Trade Union of the Self-Employed "wBREw"
 - processing of donations (Article 6 (1)(c) of the GDPR) and, if consent is given, public expression of gratitude for the donation (Article 6(1)(a) of the GDPR), for 5 years following the year of the donation,
 - to provide defence against claims and be able to pursue claims, on the basis of a legitimate interest (Article 6(1)(f) GDPR), for the time of claims limitation.
4. Consent to the processing of personal data may be withdrawn at any time without affecting the processing that was carried out on the basis of the consent expressed by you prior to withdrawal.
5. The recipients of your personal data may only be entities that are entitled to receive them under the law. On the basis of your consent, the data may also be made available to the partners of the Association.
6. You have the right to request access to your personal data and their correction. You also have the right to request the deletion or restriction of processing and object to processing, unless further processing is necessary for the Administrator to comply with a legal obligation and there are no other overriding legal grounds processing.
7. You have the right to lodge a complaint against the processing of your data by the Administrator to the President of the Personal Data Protection Office (UODO) (uodo.gov.pl).
